

VIOLATION NOTICE

On July 16, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted a review of waste shipment records as part of Consent Judgment No. 18-862-CE (Consent Judgment). The judgment became effective on December 18, 2019 to resolve violations of Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, MCL 324.5501 et seg., and Mich. Admin Code, R 336.1942.

The Consent Judgment requires the Detroit Building Authority (DBA) to post documents related to demolition activities on a publicly available website. Specifically, paragraph 5.12 of the Consent Judgment requires the DBA to make publicly available the waste shipment records for each demolition as required by 40 CFR 61.150(d)(1).

During the review, asbestos waste shipment records for several contractors could not be found online. Several notifications for each contractor were reviewed for demolition conducted between April 2019 and June 2019. A list of the waste shipment records that could not be found on the City's public website is attached.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by August 14, 3019 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
