VIOLATION NOTICE

On May 1, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted a referral inspection of the building located at 4468 W. Jefferson, Ecorse. The purpose of this inspection was to determine the owner's and contractor's compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Ms. Donna Pleso owns the building. Superior Wrecking, Inc. is the operator that demolished the building. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, it was noted that the building had been demolished without the submittal of a 10-day notice of intent to demolish to the Air Quality Division. An asbestos survey was requested but was not provided to the Air Quality Division.

Please initiate actions necessary to correct the cited violation(s) and submit a signed written response to this Violation Notice by July 1, 2019 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violation(s) occurred; an explanation of the causes and duration of the violation(s) whether the violation(s) are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation(s) and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
