SECOND VIOLATION NOTICE

On May 1, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) performed an asbestos inspection at 4468 West Jefferson, Ecorse, Michigan. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On June 10, 2019, the AQD sent a Violation Notice (VN) citing a violation discovered because of the inspection and requested a written response by July 1, 2019. A copy of this VN has been enclosed for your reference. As of the date of this letter, the AQD has not received the written response to the cited violation.

Please be advised that failure to respond in writing and identifying actions taken to resolve the cited violation may result in an escalated enforcement action by the AQD. Please provide the information requested in the VN dated June 10, 2019 by July 23, 2019, which corresponds to 14 days from the date of this letter.

The written response must be submitted to Ms. Tammy Bell, EGLE, AQD, 3058 West Grand Boulevard, Suite 2-300, Detroit, Michigan 48202, and must include a copy to Mr. Jason Wolf, Enforcement Unit, EGLE, AQD, P.O.
