VIOLATION NOTICE

On August 7, 2019, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) inspection at 26229 Michigan Avenue, Inkster, Wayne County, Michigan.

The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR) Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

According to my investigation, Abdallah Hachem owns the subject property and Albanna Construction, LLC, performed the demolition activities. The National Emission Standard for Asbestos holds both the *owner and operator* equally liable for any violations.

During the inspection, staff observed the following:

The subject facility had a notification in for the demolition of the structures on the property between the dates of July 12, 2019 and July 26, 2019. However, during our inspection of the property on August 7, 2019, several debris piles and a few standing walls remained. Several pieces of suspect asbestos containing materials such as Transite and floor tiles were noted as being present in debris piles and on parts of a remaining slab. These materials had become friable and regulated due to the excavation and pulverizing into the debris piles. As this site was unattended, the RACM was not adequately wet or contained.

Debris piles with exposed RACM unattended and dry.	40 CFR §61.145 (c)(9)	Failure to wet RACM during demolition.

Please initiate actions necessary to correct the cited violations and submit a written response to this violation notice by September 2, 2019, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
