## **VIOLATION NOTICE**

On January 16, 2020 and January 30, 2020, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted inspections of the vacant residential properties located at:

- 2659 Harding, Detroit, MI 48214 SRN# U822000248; January 16, 2020
- 2116 Harding, Detroit, MI 48214 SRN# U822000555; January 30, 2020

The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (CFR), Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, The Woodland Initiative, LLC owns the facility and Premier Group Associates, LLC performed the renovation activities at the facility. The NESHAP for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, staff observed the following:

Vacant residential properties undergoing debris clean-up and renovation activities while suspect asbestos containing materials were present. Activities were occurring prior to a thorough asbestos survey being conducted. Both companies were advised to cease operations and await survey results after the first incident on January 16, 2020 but continued work until January 30, 2020.

Please initiate actions necessary to correct the cited violations and submit a signed written response to this Violation Notice by March 5, 2020 (which coincides with 21 calendar days from the date of this letter). The response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
