### SECOND VIOLATION NOTICE

On February 4, 2022, and April 7, 2022, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted a review of waste shipment records for the asbestos NESHAP subject residential demolitions located at:

- 6008 Whitefield, Detroit, SRN U822100622
- 5904 Van Court, Detroit, SRN U822101196
- 5896 Van Court, Detroit, SRN U822106202
- 6390 Northfield, Detroit, SRN U822100490

The purpose of the inspection was to determine RDC Construction LLC's compliance with the requirements of the federal Clean Air Act; and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended; the Air Pollution Control Rules.

On May 6, 2022, the AQD sent a Violation Notice citing violations discovered as a result of the records review and requested your written response by May 27, 2021. A copy of that letter is enclosed for your reference. The response submitted was insufficient; a revised response was requested by July 6, 2022. As of this date, we have not received your updated response.

Please be advised that failure to respond in writing and identifying actions RDC Construction LLC will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our May 6, 2022 letter by August 5, 2022, which corresponds to 14 days from the date of this letter.
