VIOLATION NOTICE

SRN: U822302972, Wayne County

On July 19, 2023, the Department of Environment, Great Lakes and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of the residential property located at 2249 Fairview, Detroit. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations, Part 61, National Emission Standards for Hazardous Air Pollutants (NESHAP), Subpart M and Rule 942 of the administrative rules promulgated under Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, the Detroit Land Bank Authority owns the property. The Detroit Demolition Department manages the City of Detroit's demolition program. RDC Construction Services, LLC demolished the building. The National Emission Standard for Asbestos holds the owner and operators liable for violations.

An inspection was conducted by the AQD on July 19, 2023. The house had been demolished. The basement had not yet been removed. Dry asbestos-containing waste material (ACWM), which included, but was not limited to, cementitious siding, was noted around the property and in the basement.

A follow-up inspection was conducted on July 26, 2023. Dry, friable transite was found on site. The following violations were noted:

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by August 17, 2023 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If RDC Construction Services, LLC, the Detroit Land Bank Authority, and/or the Detroit Demolition Department believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
