**VIOLATION NOTICE**

On May 22, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection at the commercial property located at 6051 Hastings Street, Detroit, Wayne County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Fisher 21 Lofts, LLC owns the property, and Infrastructure Environmental Services, LLC conducted the abatement activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, AQD staff noted a subject commercial abatement project. A notification of intent had been filed with a start date of May 21, 2022, however upon inspection, it was obvious that abatement activities had begun long before that date. Nicole Bouie of Infrastructure Environmental Services, LLC as on-site and confirmed that abatement had begun at least a month prior. Documentation verifying asbestos survey and abatement activities at the site was provided.


