VIOLATION NOTICE

On January 8, 2025, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) performed an asbestos NESHAP (National Emission Standard for Hazardous Air Pollutants) complaint investigation at 9021 Southfield Road, Detroit, Wayne County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to my investigation, Romarta, LLC owns the subject property and performed the renovation activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for any violations.

During the inspection, staff observed the following:

A subject facility undergoing renovations. During the inspection of the property, it was noted that the required thorough inspection for asbestos was not conducted prior to said renovation activities. Building materials that were disturbed had already been removed from the property. The rebuild phase of the renovation had recently begun.

Please initiate actions necessary to correct the cited violation and submit a written response to this violation notice by February 5, 2025, (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violation occurred; an explanation of the causes and duration of the violation; whether the violation is ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violation, and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.
