Dear Interested Party:

Thank you for your interest in the two Permit to Install (PTI) applications submitted by FCA US, LLC (FCA), to the Michigan Department of Environment, Great Lakes, and Energy (EGLE). PTI Application No. 14-19A is requesting the modification of a permitted automobile assembly line under construction at the Detroit Assembly Complex Mack (Mack Plant), located at 4000 Saint Jean Street, Detroit, Michigan. PTI Application No. 33-20 is requesting the installation of a new roof coating line, relocation of a repair operation, and various refurbishments to existing equipment at the Jefferson North Assembly Plant (JNAP), located at 2101 Conner Avenue, Detroit, Michigan.

Pursuant to state and federal requirements, EGLE held a public comment period on its proposed conditional approval of the two permits that ended on September 18, 2020, including a virtual public hearing held on September 9, 2020. The Air Quality Division (AQD) received six written comments during the public comment period, four verbal comments at the public hearing, and three verbal comments via voicemail.

After careful consideration of the issues and pursuant to the delegation of authority from the Director of EGLE, I have approved PTI No. 14-19A with modifications made to the proposed permit. The final decision for PTI Application No. 33-20 is still pending at this time.

The Response to Comments Document (RTC) provides our responses to comments received during the public comment period. It also identifies special conditions which have been modified and provides our rationale for modifying the proposed special conditions. The changes are listed in Section II of the RTC. Changes made to the permit include:


PTI No. 14-19A, Mack Plant Project

- Language regarding the sealer curing oven was removed from FGNGEQUIP, Special Conditions (SCs) IV.2 & IV.3. The sealer curing oven is no longer being installed.
- Language regarding space heaters was removed from FGNGEQUIP, SC IV.3. Space heaters are not required to be direct-fired units.
