

NOTICE of AIR PERMIT COMMENT PERIOD

The Michigan Department of Environment, Great Lakes, and Energy (EGLE) is holding a public comment period and a virtual public hearing, if requested, to allow the public the opportunity to comment on the proposed conditional approval of an air permit.

There is a public comment period from March 27, until May 14, 2024, and a virtual public hearing, if requested, on May 1, for:

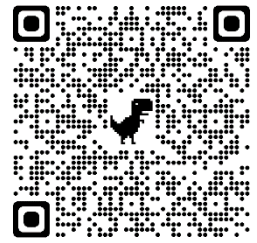
Company: Lansing Board of Water & Light (LBWL), 3725 South Canal Road, Lansing, Michigan

What LBWL wants to do: Application No. APP-2023-0209 is for a new reciprocating internal combustion engine (RICE) plant. including:

- Six natural gas-fired RICE, each rated at 29,147 horsepower.
- Two diesel-fired emergency engines, one to power a generator and one to power a fire pump.
- One natural gas-fired dew point heater used to heat natural gas before entering the RICE.
- Various natural gas-fired space heaters to be used for comfort heat.

Technical Details: The public comment period is to allow all interested parties the opportunity comment on the proposed conditional approval of an air Permit to Install. It has been preliminarily determined that the proposed plant will not violate any of EGLE's rules nor the National Ambient Air Quality Standards. The proposed plant will not exceed the available increment for particulate matter equal to or less than 2.5 microns.

Additionally, the installation of new equipment will require revisions to Renewable Operating Permit (ROP) No. [MI-ROP-B4001-2015](#). This public comment period meets the public participation requirements for a future administrative amendment to the ROP.
