Below are the comments that were discussed yesterday at our call. As I mentioned, most of the errors are typographical or formatting in nature.

- In Condition VI(1) on page 73, it is unclear whether the Permittee can continue to use the emission factor of 100 pounds of NOx per million cubic feet of natural gas consumed by FG-NaturalGas Space Heaters even if the actual measured NOx emission rate from the emission test is above the 100 pounds of NOx.
- In Condition V(1) on page 49, the Emissions Testing Schedule is in Appendix 5-1, not Appendix 1.5.
- The following conditions are missing “40 CFR” for the underlying applicable authority (UAR):
