**VIOLATION NOTICE**

On July 29, 2021, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), conducted an inspection of Grant Street Cleaners, 1190 Grant Street, Birmingham, Michigan. The purpose of this inspection was to determine Grant Street Cleaners' compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

Specifically, this dry cleaner is subject to the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (CFR), Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

During the inspection, staff observed the following:

	40 CFR 63.324(d) (1,2,3,4,5)	The NESHAP pressure, leak detection, repair, and perc purchase logs are not being kept for the perc dry cleaning machine.
	R 325.17107(a)	The still sludge and lint waste are not being stored in covered, hazardous waste containers and properly disposed of.
	R 325.17109(1)	The dry cleaning establishment is not being maintained to prevent a threat to the public (lint on floor around back of dry cleaning machine must be stored in a hazardous waste container).

Also, we recommend that you label the hazardous waste containers, store them in an area protected from the elements, and recycle the burnt out fluorescent tubes.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by August 26, 2021 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations and the dates by which these actions will take place; and what steps are being taken to prevent a reoccurrence.

If Grant Street Cleaners believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
