**VIOLATION NOTICE**

On June 8, 2017, the Michigan Department of Environmental Quality (DEQ), Air Quality Division (AQD) conducted an inspection of Quality Care Cleaners located at 39273 Grand River, Farmington Hills. The purpose of this inspection was to determine Quality Care Cleaners' compliance with the requirements of the federal Clean Air Act and Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451).

Specifically, this dry cleaner is subject to the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (CFR), Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

During the inspection, staff observed the following:

	R 325.17302(2)(4)	Owner did not pay the 2017 dry cleaning license fee and operated the dry cleaning establishment without a license until the business closed in May 2017.
	Act 451, Section 324.5522 (1)(c)	2016-2017 Category III air quality fees have not been paid.

Please initiate actions necessary to correct the cited violations and submit a written response to this Violation Notice by July 11, 2017 (which coincides with 21 calendar days from the date of this letter). The written response should include: the dates the violations occurred; an explanation of the causes and duration of the violations; whether the violations are ongoing; a summary of the actions that have been taken and are proposed to be taken to correct the violations, and the dates by which these actions will take place; and what steps are being taken to prevent a recurrence.

If Lakeshore Cleaners believes the above observations or statements are inaccurate or do not constitute violations of the applicable legal requirements cited, please provide appropriate factual information to explain your position.
