SECOND VIOLATION NOTICE

On April 17, 2018, the Department of Environmental Quality (DEQ), Air Quality Division (AQD), conducted an inspection of Huntington Cleaners, 8775 Capital Street, Oak Park, Michigan. The purpose of the inspection was to determine Huntington Cleaners' compliance with the federal National Perchloroethylene Air Emission Standards for Dry Cleaning Facilities, Title 40 of the Code of Federal Regulations (CFR), Part 63, Subpart M and the Public Health Code, 1978 PA 368, as amended, Dry Cleaning Establishment Rules Utilizing Class I, II, III, and IV Solvents.

On April 25, 2018, the AQD sent the company a Violation Notice citing violations discovered as a result of the inspection and requested your written response by May 16, 2018. A copy of that letter is enclosed for your reference. As of this date, we have not received your response.

Please be advised that failure to respond in writing and identifying actions the company will take or has taken to resolve the cited violations may result in escalated enforcement action by the AQD. Please provide the information requested in our April 25, 2018, letter by June 4, 2018, which corresponds to 14 days from the date of this letter.

Be further advised that issuance of this Violation Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under state or federal law as appropriate.
