AQD Inspection September 14, 2023

AQD staff conducted a follow-up On-site Inspection for FY 2023 of Serenity Motors (M2778), located at 32010 Michigan Avenue in the City of Wayne. The purpose of the inspection was to determine the facility's compliance with applicable state and federal air pollution rules and regulations.

For more detail on this facility, review the July 19, 2023, report. That report combines both a complaint investigation and the original On-site Inspection.

BACKGROUND:

On November 1, 1977, Wayne County Air Pollution Control issued 2 Installation Permits C-4567 and C-4568 for 1 paint spray booth and 1 paint spray room. This information can be found on microfilm.

Eric Rodson is doing business as Serenity Motors; he has been in business since June 2023. The company specializes in working with the local new and used car dealers only. No walk-in customers. This is a 1-man operation. His expectation for the paint spray room is to only paint small auto parts.

During the 7/19/2023 inspection of the paint room, there were no filters in the exhaust duct to the fan. At that time, Eric stated that he had not painted anything yet but would contact his supplier immediately and be sure to install exhaust filters before painting anything. The fan was started and working satisfactorily. There is no evidence of recent painting or the preparation to paint any parts.

The following is a summary of his text messages:

7/20/23 – text message – the filters will be delivered next Tuesday.

7/26/23 – text message – the filters arrived – however, the wrong size. getting the correct filters tomorrow.

7/31/202 – finally correct filters installed – he sent the attached photos

INSPECTION NARRATIVE:

Accompanied by the Owner, Eric Rodson, I conducted an On-site Inspection in order to verify that the correct exhaust paint filters have been installed in the paint room as reported (WC C-4568 issued November 1, 1977).

Eric stated that he has only spray painted a few small parts. The room is actually too small to do anything more. His intention is to do only minor repairs.

COMPLAINCE DETERINATION :

Based upon the results of this On-site Inspection Serenity Motors in Wayne appears to be operating in compliance with applicable air quality rules and regulations, enforceable by AQD.
