FACILITY BACKGROUND

Westrock is a corrugated cardboard manufacturer, where different types of cardboard packaging are made for the clients. The facility began operation at this location in 2021. The facility operates three shifts per day, five days per week.

REQUIRED PPE

For this onsite inspection, I wore steel toed shoes, a safety vest, eye protection and hearing protection.

COMPLAINT/COMPLIANCE HISTORY

No complaints have been received regarding this facility. No violations have been issued for this facility.

PROCESS EQUIPMENT AND CONTROLS

The facility manufactures corrugated cardboard that is typically used for boxes. The facility typically operates three shifts per day, five days per week and has been operating at this location since 2021.

INSPECTION NARRATIVE

I arrived at the facility for an unannounced inspection, which caused the facility to initially work with their legal department before allowing me to enter. Initially we discussed the purpose for the inspection as well as the process at this facility. Next, we walked through the facility to observe the process. The cardboard is printed with ink as needed. Scrap is collected in a dust collector. The visit ended with a meeting and video call with the environmental personnel regarding records. A copy of the records was emailed to me and are attached to this report.

APPLICABLE RULES/PERMIT CONDITIONS

The natural gas fired boiler is exempt from permitting by Rule 282(b) based on size. The ink printing line is exempt from permitting based on Rule 290 and proper records were collected from the facility.
