**SECOND VIOLATION NOTICE**

In January 2024, the Michigan Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD), notified Crusher Brothers, LLC (Company) for the facility located at 600 North Saginaw Street, Pontiac, Michigan, of the requirement to submit a 2023 Annual Emissions Report, with the required submittal date of March 15, 2024. In response to the non-submittal of this report, a second letter was sent on April 8, 2024, requesting immediate submittal of the MiEnviro Portal Annual Emissions Report form for the state of Michigan required pursuant to Rule 202 of the administrative rules promulgated under Part 55, Air Pollution Control, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

On June 5, 2024, the AQD sent the Company a Violation Notice (VN) citing the non-submittal of the Annual Emissions Report and requested your submittal of the Annual Emissions Report in the MiEnviro Portal by June 19, 2024. A copy of that letter is enclosed for your reference. As of the date of this letter, the AQD has not received your response.

Please be advised that failure to respond in writing and identifying actions the Company will take or has taken to resolve the cited violation may result in escalated enforcement action by the AQD. Please provide the information requested in our June 5, 2024, letter by July 9, 2024.
