ENFORCEMENT NOTICE

This letter is to advise you of the commencement of escalated enforcement action against Direct Construction Services (Company) for alleged violations that occurred at 9430 Michigan Avenue in the city of Detroit, Michigan (ID: U821709363). This letter follows the March 6 and April 13, 2018, Violation Notices issued by the Michigan Department of Environmental Quality (DEQ), Air Quality Division (AQD) which details violations of the National Emission Standards for Hazardous Air Pollutants (NESHAP) for asbestos, Code of Federal Regulations, Title 40, Part 61, Subpart M; and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (Act 451). These standards are adopted by reference in the Michigan Register 2000 MR 18, State Rule R 336.1942. These regulations hold all owners and operators, such as contractors and/or subcontractors, fully liable for compliance with the NESHAP regulations.

The AQD is hereby providing the Company with an opportunity to demonstrate compliance, present factual information in writing that should be considered regarding the cited violations and meet to discuss options for satisfactorily formally resolving the violations. The proposed formal written resolution will include, among other things, a compliance schedule within an administrative consent order and an appropriate monetary penalty.

In an effort to seek resolution of the cited federal and state air quality violations, the cited parties will be given an opportunity to discuss a resolution of this matter with the AQD pursuant to Section 5515 of Act 451, which will satisfy both state and federal requirements. <u>Please contact me at 517-284-6772, or by email at wolfj2@michigan.gov, no later than Tuesday, May 15th, 2018, to schedule a meeting to discuss the resolution of this matter.</u>

Be further advised that this Enforcement Notice does not preclude or limit the DEQ's ability to initiate any other enforcement action under federal or state law as appropriate.
