## **VIOLATION NOTICE**

On May 8, 2024, the Michigan Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection at the commercial property located at 3313 Dix Highway, Lincoln Park, Wayne County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Springs Car Park, LLC owns the property, and Royal Cement Corporation conducted the demolition activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, AQD staff noted a subject commercial demolition. No Notification of Intent to Demolish had been filed. Documentation verifying asbestos survey and abatement activities at the site was provided.

- What steps are being taken to prevent a reoccurrence; and
