Dear Cody Torrence and Ben Heckerman:

**VIOLATION NOTICE**

On July 5, 2024, the Department of Environment, Great Lakes, and Energy (EGLE), Air Quality Division (AQD) conducted an inspection at the commercial property located at 38481 Huron River Drive, Romulus, Wayne County. The purpose of this inspection was to determine compliance with the requirements of Title 40 of the Code of Federal Regulations (40 CFR), Part 61, Subpart M (National Emission Standard for Asbestos), and Rule 942 of Part 55, Air Pollution Control of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended.

According to our investigation, Romulus Huron River Drive, LLC owns the property, and ISI Demolition, through a sub-contractor – Mid Atlantic Site Support, conducted the demolition activities. The National Emission Standard for Asbestos holds both the owner and operator equally liable for violations.

During the inspection, AQD staff noted twelve commercial buildings, on the same property, in various stages of demolition. A notification of intent had not been filed for these demolitions. Documentation verifying asbestos survey and abatement activities at the site was provided.


- An explanation of the causes and duration of the violation;
